

# Notification Form SENZ-WIFI API

## 1 Processing of your personal data

- 1.1 For the purpose of providing you with the Chemelex Raychem SENZ-WIFI API services (the “services”) (the “Purpose”), Chemelex Belgium NV (hereafter “Chemelex”), will collect and process personal data about you.
- 1.2 Chemelex will collect and process the following personal data:
  - (a) User Account Information such as account name (email), password and thermostat name.
  - (b) Device Identification Information such as serial number, IP-address and MAC-address
- 1.3 All data will be treated as confidential information and will only be used for the Purpose.
- 1.4 The data is stored on a platform provided by a third party service provider. Your personal data will be stored by our platform provider outside Europe and may be accessed by Chemelex group entities worldwide on a need to know basis. Further, your personal data may be processed by our service providers, such as developer of the application, outside Europe.
- 1.5 Please be informed that the level of data protection as currently applied and enforced in countries outside the European Union does not conform to the level of data protection for personal data currently applied and enforced within the European Union. To ensure appropriate safeguards are in place when transferring personal data outside of Europe, the transfer of data between:
  - (a) Chemelexgroup entities will be based on the Standard Contractual Clauses provided by the Commission (Commission Decision 2010/87/EU).
  - (b) Chemelex and its service providers, including platform provider and developer, will be based on the Commission’s Standard Contractual Clauses (Commission Decision 2010/87/EU).
  - (c) Chemelex and a Purchaser will be based on the Standard Contractual Clauses provided by the Commission (Commission Decision 2004/915/EC).
- 1.6 You may request a copy of the data transfer agreement entered into between Chemelex Thermal Management Belgium nv and its service providers and its group entities by contacting [info@nvent.com](mailto:info@nvent.com).
- 1.7 To the extent you have not used the system for 24 months, Chemelex will delete your User Profile/Account.

Chemelex will keep a log of the changes that you make through the Application. This log will automatically be deleted after 36 month unless Chemelex is required under applicable law to keep your personal data for a longer period of time.

request that the personal data is transmitted directly to another company or person acting as a data controller.

- 1.10 Chemelex will be processing your personal data for the purpose of fulfilling the terms and conditions entered into between you and Chemelex on the provision of the services in the application.
